**WAIVER/RELEASE OF LIABILITY/COVENANT NOT TO SUE**

**2009 Great South Bay Kayak Fishing Tournament**

In consideration of being allowed to participate in any way in the 2009 Dingy Shop Great South Bay Kayak Fishing Tournament, the undersigned agrees to the following:

1. I acknowledge and fully understand that I will be engaging in activities that involve risk and damage to personal property, or serious personal injury, including permanent disability and death, and severe social and economic losses which might result not only from my own actions, inactions or negligence, but the actions, inactions or negligence of others, as a result of kayaking, fishing, wading in the water and swimming, including but not limited to perils of sea and waterways, acts of other participants, adverse sea and weather conditions, and I hereby assume complete responsibility and liability for such risks. Further, there may be other risks not known or not reasonably foreseeable at this time.

2. I assume all the foregoing risks, both known and unknown, and accept personal responsibility for all expenses, medical or otherwise, following any such damages, injury, permanent disability or death.

3. I certify that my physical condition and training are adequate to enable me to participate safely in this event.

4. I understand I have a duty to exercise reasonable care for my own safety, and I agree to do so.

5. I release, waive, discharge and covenant not to sue the Dinghy Shop, its affiliated organizations, their respective administrators, directors, agents, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and leases of premises used to conduct any part of this event, all of which are hereinafter referred to as "releases", from any and all liability to me, my heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.
